

Terms & Conditions

Contest Procedure and Rules

- The Organizers have created a contest which requires the
- To enter the competition, entrants must submit a video to the Host Website <http://www.youtube.com/group/MBNcompetition>. If a participant does not have a YouTube account, he / she can choose to create one at www.youtube.com in order to be able to upload videos and participate in the Contest.
- By joining and using "YouTube.com", participants submit to:
 - YouTube's Terms of Use found at <http://www.youtube.com/t/terms> and incorporated there by reference; and
 - YouTube's Privacy Notice, found at <http://www.youtube.com/t/privacy> and incorporated there by reference; and
 - YouTube's Community Guidelines, found at http://ie.youtube.com/t/community_guidelines and incorporated there by reference.
- Every entry to the competition will be reviewed by EuroPhysicsFun for appropriateness before being published on the Host Website.

How to enter the contest

- Beginning 25 September 2008 and continuing until 1 April 2009, you can visit the Contest Website (<http://www.europhysicsfun.org/index.php?pid=13>) for information on how and where to upload your video(s).
- Videos may **NOT**:
 - Contain any copyrighted material not in the public domain for which you have not obtained the rights to use; or
 - Contain third party voice-overs for which you have not obtained the rights to use; or
 - Contain third party stock photography or artwork for which you have not obtained the rights to use; or
 - Contain any nudity, lewd or vulgar behaviour; offensive language and/or gestures; or
 - Reference sex, drugs, or violence; or
 - Comprise content that is deemed inappropriate, indecent or obscene.

Any video submitted which is deemed by EuroPhysicsFun at his/her absolute discretion to contravene the above provisions will be disqualified from the Contest. Entrants should also note that the above provisions (in respect of inappropriate, indecent or obscene content) apply equally to information related to the Host Website including, but not limited to, an entrant's chosen user name.

- All videos submitted which have been deemed EPF to be in accordance with these terms and conditions will be posted to the Host Website. Entrants represent and warrant that:
 1. the videos they submit are their own original creations and do not infringe the rights of any other person or entity;

2. they have obtained permission, if applicable, from persons featured in the video;
 3. submission of the video will not violate any enforceable agreements or understandings the submitter has with any third party; and
 4. the video clip has not been submitted for another video contest in the past.
- Entrants can submit as many ideas as you like. Submissions must be made in English or subtitled in English.
 - Each video must be submitted in the name of one entrant only.

Judging Panel

The composition of the panel of judges will be announced publicly before the winner is announced.

Grant of Rights in Videos Submitted

Submission of a video constitutes the irrevocable non-exclusive right to EPF of all rights in the video, including all rights to use, copy, sublicense, edit, modify, make derivative works, publish, transmit, distribute, publicly perform, publish, delete or display the content of and elements embodied in the video and the video itself, in whole or in part, in perpetuity in any and all media (whether now existing or hereafter devised) without limitation, and without consideration or acknowledgment to the entrant and the unconditional right to use the idea and statements about the video for advertising/publicity purposes without additional compensation, except where such action is prohibited by law.

Cost

There is no cost to participate in the Contest. No purchase is necessary.

Prizes

Disqualification

EPF reserve the right, in its sole discretion, to disqualify any participant that it determines, in its sole discretion, is ineligible to participate in the Contest. Failure to comply with these rules may result in a participant's disqualification.

If, for any reason, the Contest is not capable of being operated as planned, including but not limited to computer viruses, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Contest, EPF reserves the right at their sole discretion, to disqualify any individual who tampers with the Contest, and to cancel, terminate, modify or suspend the Contest. EPF assumes no responsibility for any error, omission, interruption, deletion, defect, delay

in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. EPF is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any e-mail to be received by EPF on account of technical problems or traffic congestion on the Internet or at any Web site, or any combination thereof, including any injury or damage to participant's or any other person's computer related to or resulting from participation or downloading any materials in this Contest.
